Write-in candidate Mark Blue received a total of 31 write-in votes, as follows: Consolidated District #1, 19 votes; Consolidated District #2, 9 votes; and Consolidated District #3, 3 votes.

The above counts include ballots counted on November 4, 2003 at Summit County, 1 absentee ballot received after November 4, 2003 and 15 provisional ballots verified as acceptable for counting by the Summit County Clerk's Office.

Candidates Candy Erickson, Joe Kernan and Marianne Cone received the highest number votes and are hereby deemed elected to the position of City Council for a four year term, beginning January 5, 2004.
